APPLICATION PACKAGE DOCUMENTATION CHECKLIST

- Completed Application Form
- Proof of Canadian Citizenship, or Permanent Residence Status, or Refugee Status, or Work Permit, or Study Permit. Accepted documents for proof of status include Canadian birth certificate, Canadian passport, Certificate of citizenship, Certificate of Indian Status, Landed immigrant papers, Permanent resident card, Confirmation of permanent residence status document, Verification of status document, Work permit, and Study permit.
- Proof of English language proficiency if English is not your first language. Accepted documents for proof of English language proficiency include Canadian English Language Benchmark Assessment for Nurses (CELBAN) test scores and International English Language Testing System (IELTS) test scores.
